It was also suggested that the City should control any and all monev that comes into the City. I guess this is a new policy that is reserved only for GCAC. As an example, the City did not and does not control the money in 2 of the 3 grants held by "It Takes a Village", by any grants held by SOMOS, nor did the City control how the funds were used by the Long Term Recovery Committee. Not a very balanced approach.

Please take a moment and think about what the City has done over the last decade to revitalize the community. I truly believe that most have tried their best to improve conditions. but the weight of responsibility in the City can wear down the best and brightest. When you have a municipality that is shrinking yearly along with the tax base, 40% of the land area in the City is not taxable and of contributing to the tax base, plus a deteriorating infrastructure you have a recipe for disaster (see Detroit).
